Details of each component are detailed as above. Families are encouraged to set up weekly or fortnightly Automatic banking payments. Contributions are invoiced termly and in advance; the expectation is that accounts are up to date by the end of each term.

The contributions detailed above show the GST-exempt portion which qualifies for the Donation

Income Tax Rebate. A Donation Tax Receipt will automatically be emailed after the 31st March each year but will also be available on request.

Attendance Dues

Attendance Dues are used to repay loans for building works done at schools in the Auckland Diocese, property related costs including school building works, buildings insurance and costs directly associated with the administration of Attendance Dues.

Attendance Dues are collected by St Ignatius of Loyola Catholic College on behalf of the school's Proprietor, the Roman Catholic Bishop of Auckland. These are forwarded to the Auckland Common Fund Limited, a company established by the proprietors of Catholic-integrated schools in the Diocese of Auckland responsible for the collection of Attendance Dues.

More information is available from the School Administrator on Attendance Dues or if you need any assistance. This portion does not qualify for the Donation Income Tax Rebate.

St Ignatius of Loyola Catholic College Board Financial Contribution

This will be required by the St Ignatius of Loyola Catholic College Board of Trustees to cover a wide range of costs that are not met by the Ministry of Education. This contribution is to cover extra resources for the benefit of students including additional staffing, co-curricular sports and musical equipment, additional curriculum learning equipment and materials such as digital resources, subsidising the school Year Book, and any other expenditure on behalf of the students as may be approved by the board. A percentage of this contribution will be forwarded to the Auckland Catholic Diocese for the ongoing capital works development of the college. This contribution is subject to change should the Board see fit to alter it. *This contribution is GST exempt: tax deductible.*

Proprietors Contribution

This contribution is forwarded to the Auckland Catholic Diocese for the on-going capital works development of St Ignatius of Loyola Catholic College. *This contribution is GST exempt: tax deductible.*

Special Character Contribution

This contribution provides the main source of funding for all services provided to St Ignatius of Loyola Catholic College by the Catholic Education Services Board. No contributions are made by the Government for these services. The Catholic Education Services Board assists schools to provide a Catholic education for your child through the preservation and enhancement of the Catholic Special Character in our schools. *This contribution is GST exempt: tax deductible.*

Subject and Activity Fees

Students will be charged for various activities and subject fees which involve a take home component for the options they have chosen. This includes costs such as materials, field trips, retreats, subject competitions subject-specific workbooks.

Other activity charges will be added as they are advised by various departments throughout the year. These are due as soon as they are added to your account.

Some curriculum areas also offer competitions in their subject. Charges for these are passed on as well.

Learning Enhancement Platforms

Students are offered various learning enhancement platforms to enable them to access licenses to learning platforms both at home and at school. Subscriptions for essential platforms for students to access their learning will be added to student accounts at the beginning of each school year.

Camp (Year 7 & Year 10) \$365

Year 7 and Year 10 students attend a school camp. You will be notified of the cost for this early in the year along with a timeline around expectation of payments. Non-payment of dues and charges may mean your child will be unable to attend their year level camp.

Extracurricular Activities

The College offers a large variety of co-curricular activities in sporting, music, cultural and EOTC areas where students are encouraged to participate.

If your child has chosen to participate in any of these there may be a charge to cover registration, hireage, equipment, uniforms, travel and staff relief etc. Charges will be added to your account and need to be paid promptly, or a payment plan as agreed with the accounts department may be put in place to enable your child to participate.

Please note our operational guidelines state – No Pay, No Play for all extra-curricular activities.

If your child wishes to be considered for an overseas trip, partake in a sports tournament, or be involved in an EOTC pursuit, all dues must be up to date before consideration will be given.
