Discussion of the plans – changing rooms and bathrooms will be external so will be accessible to courts as well. Particularly useful when hosting teams as there won't be access to main buildings. The Gymnasium will be basic but functional. Aesthetically it will tie the utility sheds to the main College buildings.

Finance – the Proprietor (Bishop Steve) will take on the loan to build the building from the Auckland Common Fund. Our proprietors' contributions will repay the loan as well as half of the Board contributions. This will be paid off over approximately eight years.
