Subject and Activity Fees

Students will be charged for various activities and subject fees, which involve a take-home component for the options they have chosen. This includes costs such as materials, field trips, retreats, subject competitions, and subject-specific workbooks. Other activity charges will be added as they are advised by various departments throughout the year. These are due as soon as they are added to your account. Some curriculum areas also offer competitions in their subject. Charges for these are passed on as well.

Learning Enhancement Platforms

Students are offered various learning enhancement platforms to enable them to access licenses to learning platforms both at home and at school. Subscriptions to essential platforms for student learning will be added to student accounts at the beginning of each school year.

Year 10 Camp Approx. \$370

Year 10 students attend a school camp. You will be notified of the exact cost for this early in the year, along with a timeline for expected payments. Non-payment of dues and charges may mean your child will be unable to attend their year-level camp.

Extracurricular Activities

The College offers a wide variety of co-curricular activities in sporting, music, cultural, and EOTC areas, encouraging student participation. If your child has chosen to participate in any of these, there may be a charge to cover registration, hireage, equipment, uniforms, travel and staff relief, etc. Charges will be added to your account and must be paid promptly; otherwise, a payment plan, as agreed with the accounts department, may be put in place to enable your child to participate.

Please note our operational guidelines state – No Pay, No Play for all extracurricular activities.

If your child wishes to be considered for an overseas trip, to participate in a sports tournament, or to be involved in an EOTC pursuit, all dues must be up to date before consideration will be given.
